

<p><b>DOCUMENTS REQUIRED</b></p>	<ul style="list-style-type: none"> <li>▪ Original passport</li> <li>▪ "Attestation Reservation de cale"</li> <li>▪ Letter of transfer from the shipper's employer</li> <li>▪ Inventory (four copies) detailed, valued, in French, signed and dated by shipper, and consularized at origin (Describe all stereo, video and radio equipment, including make, model and serial number)</li> <li>▪ Letter authorizing Destination Agent to clear shipment</li> </ul>
<p><b>CUSTOMS REGULATIONS</b></p>	<ul style="list-style-type: none"> <li>▪ SHIPPER MUST BE PRESENT AT CUSTOMS CLEARANCE</li> <li>▪ All shipments inspected</li> <li>▪ Personal effects may be duty-free</li> <li>▪ Shipments must arrive within four months of customer</li> </ul>
<p><b>DUTIABLE/ RESTRICTED ITEMS</b></p>	<ul style="list-style-type: none"> <li>▪ Food and consumable items: All canned meat products (including pork, sheep, fish, chicken, etc.) must have Certificate of Health</li> <li>▪ Electrical items and furniture must be more than six months old, otherwise, they are subject to Customs duties and taxes</li> <li>▪ Invoices required</li> <li>▪ Home computers are not accepted as personal effects and are subject to Customs duties and taxes</li> <li>▪ Books and tapes (audio and video) require an agreement from the Interior Ministry. No more than 25 audio and video tapes can be imported</li> <li>▪ Firearms require an agreement from the Defense Ministry</li> <li>▪ Phones and faxes require an agreement from Telecoms and Post</li> </ul>
<p><b>PROHIBITED ITEMS</b></p>	<ul style="list-style-type: none"> <li>▪ Weapons, ammunition, military equipment</li> </ul>

	<ul style="list-style-type: none"> <li>▪ Drugs and narcotics</li> <li>▪ Alcohol and other spirits are prohibited and should be sent separately</li> <li>▪ Animal skins, stuffed animals, birds or fish</li> <li>▪ CBs and walkie-talkies (including children's toys)</li> </ul>
<b>MOTOR VEHICLES</b>	<ul style="list-style-type: none"> <li>▪ High duties and taxes apply</li> </ul>
<b>PETS</b>	<ul style="list-style-type: none"> <li>▪ Certificate of good health dated within three days of arrival</li> <li>▪ Rabies vaccination (within 30-180 days prior to arrival)</li> <li>▪ Shipping as unaccompanied baggage not recommended</li> </ul>
